

MATCH POLICIES

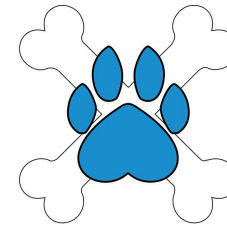
- Walk-thru/briefing will take place from 5:30-5:45PM (for match #1) and 7:00-7:15PM (for match #2). **Exhibitors must check in by the end of the walk-through.**
- Run order will be roughly small-to-tall, both matches. **We will run through the jump heights multiple times to accommodate handlers running multiple dogs, or running the same dog(s) more than once** and will split up jump heights if necessary.
- Maximum course time: **90 seconds**. Time starts when you remove your leash or cross the plane of the first obstacle to place a toy/treat/training prop.
- **Exhibitors may use the following devices in the ring:**
 - Toys, including those that squeak/rattle/make noise
 - Food treats
 - Clickers
 - Targets, hoops, stride regulators, hit-it boards
- Harsh handling of a dog (including physical corrections, use of prong or electric collars) on the event grounds *will* result in excusal from the match with no refund.
- Ring crew will be present and a volunteer judge is available by request.

Pre-Entry Rates:

\$10 for first run - **\$7** for each additional run. (Per dog)
Maximum 3 runs per dog, per match.

Day of Match Rates (if time allows): \$12 per run

Course map & availability of additional runs will be posted to the Crossbones Dog Agility Facebook page (www.facebook.com/crossbonesdog) by 10AM on May 16th.

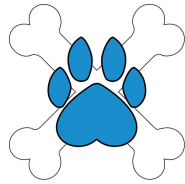
