**Rules to Enter:**

- Dogs must be at least 12 months of age.
- Dogs must compete in their regulation/preferred jump height.
- Dogs eligible to be registered with the AKC or Canine Partners program are welcome!

**Exhibitor Rules:**

- Toys are allowed in the ring, no food or treats.
- 90-second maximum course time.
- Handler must attempt to run the course; practicing just one piece of equipment is not allowed.
- No harsh verbal or physical training allowed.
- Excusal for handler swearing in the ring.
- Excusal for dog defecating or vomiting in the ring.

**General Information:**

- Classes offered: Novice Standard  
Open Standard  
Excellent Standard
- Match judging will commence 30 minutes after conclusion of the day's trial.
- All pre-entries will run first, followed by day-of-trial entries.
- There will be no scoring, ribbons or prizes.
- Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by action of the trial committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the trial, no refund of entry fees will be made.

**Pre-entry Fees:**

\$8 for the first entry of each dog.

\$5 each for the second and third runs of the same dog.

*Pre-entries must be received by Wed., April 20, 6 p.m.*

**Day of Match Entry Fees:**

\$10 first entry each day per dog

\$5 each subsequent entry of same dog.
