### **GENERAL**

- *Please consult TMAC's Covid Plan enclosed in your Premium. This trial was formulated to comply with the State of CT Reopening Plan.*
- *Everyone on-premises, both inside and outside the building, must wear a mask at all times unless you are sitting inside your vehicle. Exhibitors must wear a mask while competing, with no exceptions. You must bring your own mask; however, a limited supply is available if your mask should break or be misplaced. See the trial Chairman or Co-Chairman to request a new mask. Exhibitors should maintain six-foot social distancing while inside and outside the building. Please be respectful of your fellow exhibitors.*
- *Food and beverages will not be offered at the trial. Exhibitors should plan to bring any food or drink they wish to have during the day. Please do not bring MACH cakes or desserts to share with exhibitors.*
- *Only dogs entered in this trial may be measured by a VMO. If a dog is not able to stand on a table with someone sitting by them it may not be possible to complete a measurement.*
- *A limited quantity of paper course maps will be available onsite. The trial secretary may post the course maps online the evening before each day. Maps will be posted onsite at the beginning of each day, both outside the main building and in the indoor crating area, for exhibitors to take pictures. Running orders, check-in sheets, and results will be posted in the crating area.*
- *Ribbons will not be self-serve. A worker will place stickers on ribbons for exhibitors to retrieve at a table.*
- *A seating/viewing area will not be available in the main room; chairs will not be allowed in the main building except for individuals in designated roles. Exhibitors may bring personal chairs to the crating area. An area will be designated to accommodate capturing video, with no more than three videographers permitted at a time.*
- *Briefings will be held outside of the building, weather permitting. If conditions do not permit an outdoor briefing, separate, small-group briefings may be conducted in the main building or in writing. Walkthroughs will be limited to approximately twenty or fewer handlers. Please be sure to check the gate sheets to see when you will walk.*
- *Five or fewer teams will be allowed in the building to queue up for runs. A gate steward will be stationed at the entrance to direct exhibitors when to enter the building for walk-thrus and classes.*
- *Please refrain from entering the main building unless you are running your dog or working a class. Two restrooms will be available in Little Paws for exhibitor and volunteer use; the restrooms in the main building will not be available.*

- *Thank you to everyone who has volunteered to work. Please check with the Co-Chairman or Ring Master as there may be changes to the procedures that you need to know.*
- *As always, please clean up after your dog.*

**PARKING**

- *With the limited number of exhibitors each day, there should be ample parking.*
- *A portion of the upper parking lot will be reserved for exhibitors who are working from their vehicles.*

**CRATING**

- *Crating space will be limited and appropriately spaced to ensure distancing and will be available on a first-come, first-served basis. Un-entered dogs will not be permitted in the crating area.*
- *Little Paws will be available for crate set up beginning Saturday at 6:30 AM. Please do not congregate in Little Paws. Occupancy is limited to fewer than 25 people. Please remove all crates and items from Little Paws after your trial, even if you are coming back on Sunday.*

**Directions to the trial site 36 Corporate Ridge, Hamden, CT 06514**

**I-91:** Take Exit 10 (Rt. 40) to end, Right on Rt. 10 (Whitney Avenue), go approx. 1.5 miles, turn left on Sherman Avenue (Dunkin' Donuts), 1.1 miles, turn right on Corporate Ridge. Continue up Corporate Ridge to #36. The building is on the left.

**Rt. 15 S:** Take Exit 62 (Whitney Avenue North). Follow as above.

**Rt. I-84:** Exit onto I-691, first exit (Cheshire, Rt. 10, South), follow Rt. 10 through Cheshire into Hamden (Rt. 10, Whitney Avenue), take right onto Sherman Avenue (Dunkin' Donuts), follow as above.

**Rt. 15 N:** Take Exit 60 (Dixwell Avenue), left at end of exit, 0.8 miles, bear left at Duchess Diner, go through light onto Shepard Avenue, four lights, right onto Sherman Lane, 1<sup>st</sup> left onto Sherman Avenue, go 1.5 miles. Take a left onto Corporate Ridge. Continue up Corporate Ridge to #36. The Building is on the left
