

Welcome to the 23rd Annual November Cluster 2019 AKC All Breed Agility Trial!

We are again very excited to be a part of this wonderful dog show weekend with 3 buildings hosting 3 different venues of dog sports. There is a lot of information included below, along with changes to judging assignments. Please take the time to read the full confirmation. We are doing our best to provide you with an exceptional experience!

Confirmation Information

- Please make note of the information below and contact me at noreen@pawprintrials.com if you have any questions. Download the complete confirmation letter from my website for the full schedule of times and walk thrus. Your estimated **scheduled run order** is included below.
- A **published run order** will be provided after all move ups have been completed. On Tuesday, you may view the published run order for each day by clicking on www.pawprintrials.com.
- Instructions to access to **Real-Time Run-Order** is outlined below. On the day of the trial, it is recommended to use Real-Time Run-Order for the most up to date information.

Attention all Exhibitors

- Unfortunately, we were just notified that Cherie Tyre-Roberts fractured a bone in her foot and will be unable to judge. Zach Davis will judge Cherie's assignment. Any courses designed by Cherie Tyre-Roberts will still be used.

Attention 20" Preferred Exhibitors

- In order to balance the ring times, it was necessary to reassign the 20" Preferred in some classes. Please be sure to check the ring assignments.

Attention Open Standard Saturday Exhibitors

- In order to balance judging assignments, Open Standard will be judged by Erin Schaefer. Erin will be judging courses designed by Katrina Walters.

Briefings

- Written briefings will be posted at each ring, in lieu of verbal briefings, before each class. Please read the full briefing.
- Novice and Open classes will still have verbal briefings, as well as all levels of FAST.

Maps

- There will be paper maps available for each day. Maps will also be posted on my website with a copy of the briefing.

Waiver

- The Eastern States Exposition is requiring a signed waiver for all participants. [ESE Waiver](#) There will be a box near the volunteer area. Though it's not required, we recommend wearing a mask and using hand sanitizer frequently throughout the event. We have decreased the number of exhibitors in each walk thru to keep social distancing. Remember to maintain 6 feet between other exhibitors whenever possible. Please be conscious of this when talking with volunteers and especially our gate steward.

General Information

- In order to allow the scorekeeping to run as efficiently as possible, there will be LEAP/TMAC members available for questions at the VOLUNTEER booth. The scorekeepers can assist you if your class information is incorrect. All other questions should be directed to the VOLUNTEER booth.

Food

- The Mallary building will be providing a variety of food for purchase.

Set-Up

- The grounds will be available for set up on Wednesday from 3:30 p.m. to 7 p.m. PLEASE DO NOT ARRIVE EARLY. There are many vehicles unloading equipment and for your safety, exhibitors are not allowed to enter the Mallary Arena before 3:30 p.m. on Wednesday. The building will also be open on Thursday from 3:00 p.m. to 5:30 p.m.

Crating Space

- Per the premium, X-pens will be limited to 8 panels, for 3 or more dogs. No multiple X-pen setups.
- Puppy Play Pens may be limited to 2 or more dogs.
- LOUNGE CHAIRS and TABLES will not be allowed, and we ask that you stack crates whenever possible.
- There will be no 'preferred' crating. Please be respectful of the trial committee if you are asked to move your setup to make room for others. Crate-aggressive dogs must be covered and may not be positioned on the corners of aisle ways or other heavy traffic areas. This will be enforced and if complaints are received, dogs will be moved. If you crate on the Ring 1 side and are staying for Monday, you will need to relocate to the Ring 3 side on Sunday night.

Prior-Day Check-In and Conflicts

- Prior-Day Check-In will help ease the morning rush to check-in and alleviate crowding around the gate sheets. You may check yourself in, mark yourself absent or mark yourself conflict. For more detailed information, refer to our previous document [General Info](#)
- If you have a conflict with another entry in Conformation, Rally or Obedience, you must inform the gate steward of the conflict or mark conflict if you check-in the previous day. If the gate sheet is not marked with a conflict and you miss your run, you will not be able to run.
- The MBF judging program is available for Conformation, Rally and Obedience. If you expect to have a conflict, please email noreen@pawprinttrials.com. Include your name, call name, jump height, and class that you are running. Include which sport is creating a conflict; Conformation, Obedience or Rally. Please provide hours that you WILL NOT be able to run and we will try to move your dog to avoid any conflict. All conflict information must be received by Sunday at 6pm.

Real-Time Run-Order

- Real-Time Run-Order will be in use for this trial. Click on Run-Order at the top of my screen each day. For more detailed information, refer to our previous document [General Info](#)

Live Streaming

- For the first time, we will also have live streaming available, for each ring, all 4 days. The link will be available when you click on the Real-Time Run-Order. This is a great way for your friends and family to watch you in action. The Northeast Agility Championship will only be live on AKC TV.

- We have a few runs left for our B Match on Friday. The match will begin when ALL RINGS have finished judging. You may sign up online until Monday, November 26th. Novice is full but you may run in Open or Excellent. [Enter Match](#)

FROM THE SOUTH via I-91: Take Exit 3 South marked "Route 5, Columbus Ave., Agawam, West Springfield". Follow Route 5 North to Route 147 West for approximately $\frac{3}{4}$ mile to The Big E Gate 9 entrance on the left.
