Classes: 3 runs offered in the following order:

- 1. ISC Style Jumpers
- 2. ISC Style Agility
- 3. EO Style Team Agility Relay (4 team members jumping the same height)

<u>Entry:</u> \$25/class. May enter any of the courses. Ability to sign up as a team or to sign up for team and we will combine entrants into a Team. On-line entry at <u>www.pawprinttrials.com</u> or see the last page of this document. **Entry opens on 3/1/2022, closes on 4/8/2022.** Please see Note on on-line entry if new to Pawprint trial next page.

<u>Courses</u> are designed by world famous 2022 EO Judge Thora Van Der Stock, judged by the amazing Sheyla Gutierrez.

Eligibility: Open to all AKC Heights, both Regular and Preferred. Dogs must be 18 months or older. BIS allowed.

Scoring: Preferred dogs will be judged against their regular height peers (ie. P16" with 20").

1. Jumpers and Agility: Time plus faults. Faults are knocked bar, missed contact, refusal, missed weave-pole entry or missed pole, etc. Each Fault is 5 points. 3 Faults are an Elimination. Wrong course is Elimination. Lowest score without Elimination wins. There will be individual class winners, but the 2 courses results will not be combined.

- 2. Team Agility Relay: 4 members of the same jump height will run different sections of the same course. Each section is about 19-21 obstacles. Also scored as Time plus faults, cumulative for the team. Lowest team score wins.
- 3. FEO allowed in the ISC Style Jumping and Agility courses, standard course time will apply.
- 4. Fix and Go allowed 1x/course.

Awards:

- 1. Qualifying ribbon for all clean runs;
- 2. Placement ribbon and Podium for top 3 placements of each height
- 3. The FCI Height (12", 16", 24") winners of each of the Jumpers and Agility classes will be entered into a raffle to win a Wildcard Bye (1 for each heights) to the prestigious **Avalon Cup Finals in**France, the weekend before the EO. In the event there are no winners in a height, the winners will be combined to select the 3rd bye winner.

Facility and Equipment: Turf with virgin rubber fill; Clip and Go, Galican and MAD Agility equipment. There will be no table in any of the Agility courses. A-Frame height will be 5' for 4" and 8" dogs, 5'6" for all other heights. Electronic timing.

There is Restroom in the Lobby area of the building. Please, no dogs in the lobby at any time. The building is heated / cooled as needed.

Run order: Will be rotated between classes, as well as within heights – please see confirmation

COVID Protocol: We will observe the state and town regulations at the time of the trial. Please be flexible as these can change on short notice. Masks may be required at all time at this event; fully vaccinated people may be able to lower their mask while running – please see final confirmation.

<u>Food:</u> No food services available; please bring your own.

Water for dogs available from the restrooms/lobby area.

Music: may play during building and walk-thru, but not during any runs.

Parking: Plenty of parking around the Fieldhouse

<u>Crating:</u> There will be crating available inside the building, in the turf. Please bring a tarp for under your crate/chair.
