- Please note there has been a change in the running order for Sunday Premier Standard. 24's will run after 16's, then 20's will run. This was necessary in order to avoid conflicts.
- **Please note the start times for Saturday. Ring 1 starts at 8:00am and Ring 2 starts at 8:45am**

## Team Competition

- The catch is that you do not get to pick the teams. You will be randomly assigned to a team. In other words teams will be made via a "blind draw".
- There will be 3 handler/dog teams assigned to each team.
- Results will be based on scores for Standard and JWW on Saturday, where a clean run is worth 150 points for standard and 100 points for JWW.
- The speed of the 3 handler/dog teams will be the tie-breaker.

## Jump Height Cards

- This trial will have a Volunteer Measuring Official. All dogs that need to be measured must be measured before their run. Measuring will occur all day.

## Food

- Star Hill Cafe will be open with a **limited** menu. You may wish to bring your own food and water.

### Prior-Day Check-In

- You may check in the day before the trial online by clicking Prior-Day Check-In at the top of my website. You may check yourself in or mark yourself Absent, if you know you will be unable to attend. This will decrease the number of people crowding around the gate sheets. Prior-Day Check-In will only show the day before the trial and is available from noon -5pm only. After 5pm, this feature will be shut off to allow us to print gate sheets for the next day.
- You can receive a text alert, at noon, as a reminder to check-in. You may enable this feature by going to my website, click on your name and then ALERTS.

### Real-Time Run Order

- Real-Time Run-Order will be in use for this trial. Click on Run-Order at the top of my screen each day. The run order will update every few minutes. This will allow you to plan when you will be in the ring with your dog.

### Results Matter

- All results will continue to be posted after the trial. Our new feature will keep track of results for your dog. You may access these results by clicking on your dog's name in your record OR by clicking on **My Entries/Results**. Results will be posted throughout the day.
- You can get a text alert with your results sent directly to your phone, by the end of each class. Sign up for Alerts by clicking on your name, then **Alerts**. We hope you enjoy these new enhancements to PawPrint Trials
