# Prior-Day Check-In

- You may check in the day before the trial online by clicking Prior-Day Check-In at the top of my website. You may check yourself in or mark yourself Absent, if you know you will be unable to attend. This will decrease the number of people crowding around the gate sheets. Prior-Day Check-In will only show the day before the trial and is available from Noon -5:00 p.m. only. After 5:00 p.m., this feature will be shut off to allow us to print gate sheets for the next day.

## Real-Time Run Order

- There are specific areas to walk your dog and specific areas to be avoided as outlined in the Field House correspondence. Please adhere to these rules.
