Prior-Day Check-In

- You may check in the day before the trial online by clicking Prior-Day Check-In at the top of my website. You may check yourself in or mark yourself Absent, if you know you will be unable to attend. This will decrease the number of people crowding around the gate sheets. Prior-Day Check-In will only show the day before the trial and is available from Noon -5:00 p.m. only. After 5:00 p.m., this feature will be shut off to allow us to print gate sheets for the next day.
- You can receive a text alert, at Noon, as a reminder to check-in. You may enable this feature under ALERTS.

Real-Time Run Order

- Real-Time Run-Order will be in use for this trial. Click on Run-Order at the top of my screen each day. The run order will update every few minutes. This will allow you to plan when you will be in the ring with your dog.

Results Matter

- All results will continue to be posted after the trial. Our new feature will keep track of results for your dog. You may access these results by clicking on your dog's name in your record OR by clicking on **My Entries/Results**. Results will be posted throughout the day.
- You can get a text alert with your results sent directly to your phone, by the end of each class. Sign up for Alerts by clicking on your name, then **Alerts**.

- We will have live streaming available. The link will be available on the day of the trial by clicking on [The Fieldhouse](#)

Maps

- Maps will be posted at www.pawprinttrials.com by 7:00am the morning of the trial, per AKC.
- No paper copies of maps will be available onsite.

Food

- No onsite food or water will be available to purchase.
- A microwave and kitchen sink are located in the lobby for exhibitor use.
- No dogs are allowed in the lobby. You may eat in the lobby.

Set Up

- Exhibitors can set up any time after 7:00 am
- Walk thrus begins at 7:45 a.m., judging begins at 8:00 am both days.

Field House Info

- Please remember to pick up poop and exercise your dog prior to running your course. Toilet accidents within the facility, including the ring, are subject to site policy.
- Please do not allow your dog to toilet directly on the building, outside equipment, or on the young trees as this causes erosion to the building/equipment and can kill the saplings.
- There are specific areas to walk your dog and specific areas to be avoided as outlined in the Field House correspondence. Please adhere to these rules.

The first height in each class will be rotated as well as the run order within each height.
