

Welcome to the 26th Annual Thanksgiving Cluster 2024 AKC All Breed Agility Trial!

We are again very excited to be a part of this wonderful dog show weekend with 3 buildings hosting 3 different venues of dog sports. There is a lot of information included below, along with changes to judging assignments. Please take the time to read the full confirmation. We are doing our best to provide you with an exceptional experience!

Confirmation Information

- Please make note of the information below and contact me at noreen@pawprintrials.com if you have any questions. Download the complete confirmation letter from my website for the full schedule of times and walk thrus. Your estimated **scheduled run order** is included below.
- A **published run order** will be provided after all move ups have been completed. On Tuesday, you may view the published run order for each day by clicking on www.pawprintrials.com.
- Instructions to access **Real-Time Run-Order** is outlined below. On the day of the trial, it is recommended to use Real-Time Run-Order for the most up to date information.

Attention all Exhibitors: Please note there are a couple of judge assignment changes in order to keep the trial moving. You must trial under the judge that is assigned to your class/jump height.

Friday, November 22

- Premier Std 20" will be judged by Ben Gibbs
- Masters Std 8" will be judged by Dale Mahoney

Saturday, November 23

- T2B 16P", 20P" & 24"" will be judged by Jan Skurzynski
- T2B 4"-12" will be judged by Erin Schaefer
- Masters Std 20P" will be judged by Erin Schaefer
- Masters JWW 24" will be judged by Erin Schaefer

T2B may be judged in a different ring than the rest of your classes. Please check the schedule for specifics. This will allow us to keep rings moving efficiently.

Briefings

- Written briefings will be posted at each ring, in lieu of verbal briefings, before each class. Please read the full briefing.
- Novice and Open classes will still have verbal briefings, as well as all levels of FAST.

Maps

- There will be paper maps available for each day. Maps will also be posted on my website with a copy of the briefing.

General Information

- In order to allow the scorekeeping to run as efficiently as possible, there will be LEAP/TMAC members available for questions at the VOLUNTEER booth. The scorekeepers can assist you if your class information is incorrect. All other questions should be directed to the VOLUNTEER booth.

Food

- The Mallery building will be providing a variety of food for purchase.

Set-Up

- The grounds will be available for set up on Thursday from 3:00 p.m. to 7:00 p.m. PLEASE DO NOT ARRIVE EARLY. There are many vehicles unloading equipment and for your safety, exhibitors are not allowed to enter the Mallery Arena before 3:00 p.m. on Thursday.

ADMIT FOR LEAP/TMAC AGILITY SETUP MALLERY BUILDING THURSDAY, NOVEMBER 21 ONLY.

- There are Conformation and Rally shows on Thursday so parking fees will be collected. If you are showing in Conformation or Rally, you are expected to pay the regular parking fees. If you are setting up for Agility on Thursday, present this notice to the parking attendant in order to avoid the parking fee. If you do not show this, you will be required to pay the \$5 parking fee. You may print a hardcopy or show it on your phone.

Crating Space

- Crating is back-to-back. The back of each crate goes against the tape.
- Per the premium, X-pens will be limited to 8 panels, for 3 or more dogs. No multiple X-pen setups.
- Puppy Play Pens may be limited to 2 or more dogs.
- LOUNGE CHAIRS and TABLES will not be allowed, and we ask that you stack crates whenever possible.
- ****SPECIAL RESERVED CRATING **** If you reserved crating, the name of of the person that reserved the crating will be written on paper in the assigned area.
- There will be no "preferred" crating. Please be respectful of the trial committee if you are asked to move your setup to make room for others. Crate-aggressive dogs must be covered and may not be positioned on the corners of aisle ways or other heavy traffic areas. This will be enforced and if complaints are received, dogs will be moved. If you crate on the Ring 1 side and are staying for Monday, you will need to relocate to the Ring 3 side on Sunday night.

Prior-Day Check-In and Conflicts

- Prior-Day Check-In will help ease the morning rush to check-in and alleviate crowding around the gate sheets. You may check yourself in, mark yourself absent or mark yourself conflict. For more detailed information, refer to the initial two confirmations [General Information](#).
- If you have a conflict with another entry in Conformation, Rally or Obedience, you must inform the gate

steward of the conflict or mark conflict if you check-in the previous day. If the gate sheet is not marked with a conflict and you miss your run, you will not be able to run.

- If you expect to have a conflict with Conformation, Obedience or Rally, please email me with the times of your conflict and I will move you in the running order. Please email by Monday 10:00 a.m.

Real-Time Run-Order

- Real-Time Run-Order will be in use for this trial. Click on Run-Order at the top of my screen each day. For more detailed information, refer to our previous document [General Info](#).

Live Streaming

- We will have live streaming available, for each ring, all 4 days. The link will be available when you click on the Real-Time Run-Order. This is a great way for your friends and family to watch you in action. The Northeast Agility Championship will only be live on AKC TV.

AKC Sanctioned B Match

- The match has a few spots left. The match will begin when ALL RINGS have finished judging.
- A separate email will be sent to those entered in the B Match.

- Please note, the clubs reserve the right to use the first available ring for last class of the day or alter the order of classes to maintain an efficiently run trial.
