## Move-Ups

- Move-ups **must be processed by 6pm on Monday, May 11, 2026**, per AKC.
- If you paid on-line, you may process your move-up by going to [www.pawprinttrials.com](http://www.pawprinttrials.com) and then click on MY ENTRIES and then MOVE-UP and change the appropriate class.
- If you mailed your entry in, you must email me to request a move-up. Please include the class you are moving from and the class you are moving to.
- **No move-ups will be done after the posted deadline.**
- **If you earn a title during the trial, you must complete a move-up form and submit it before the end of the day. On-line move-ups are not allowed. If a move-up form is not submitted at the trial, your move-up cannot be processed.**

## Jump Height Cards

- All dogs competing in agility must possess an Official AKC or valid yellow measuring form.
- This trial **WILL NOT have a VMO.**
- All dogs that DO NOT HAVE a temporary yellow measuring form (dogs under 2 years old) or permanent card (dogs 2 years or old) must be measured PRIOR to running.
- Measuring will occur throughout the day.
- Please use the running order to plan and arrive in plenty of time to be measured before you walk your first course.

## Judge change

- Our judge Greg Fontaine has unfortunately been injured and is unable to judge. We are grateful and very lucky that two of our local judges have given up the opportunity to trial and have stepped up to help the clubs due to this emergency.
- On Saturday, Cara Armour will be judging in place of Greg Fontaine and will also be judging 4-12" P FAST due to load balancing.
- On Sunday, Lisa Loomis will be judging instead of Greg Fontaine.

## WWIS Food and Drink

- **PLEASE** remember -no food or drink is allowed on the turf, other than water.
- Food is allowed to treat dogs.
- **ABSOLUTELY NO COFFEE** on the turf. Not only does it ruin the turf, the club is financially responsible.

## Set Up

- Set up on Friday after 3pm ONLY
- Exhibitors can set up any time after
- The arena will be open for setup ONLY from 1:00 to 4:00 pm on Friday.

## SITE INFORMATION

We are very fortunate to be allowed use of the Wide World of Sports. It is imperative that ALL exhibitors follow the guidelines and rules in order to maintain this facility.

All exhibitors must pick up after their dogs.

**NEW RULE:** Dogs MAY NO LONGER relieve themselves near or in the area adjacent to the building.

- **There are 2 areas to use for potty areas: Dog relief area is down the stairs to large grassy area or in the adjacent fields, but NOT near the building.**
- Absolutely no dogs will be allowed near the dome at the rear of the building for any purpose. Violators will be held accountable to the clubs and the AKC.
- No food or drink in the exhibitor area on the tarps. If coffee or anything is spilled, it will stain and will not be allowed to have dog shows.
- Please place mats under your crates to prevent leaks and tears.
- There are 2 areas to use for potty areas:
  - Dog relief area is down the stairs to large grassy area or in the adjacent fields, but NOT near the building.

## Food

- There will be food available for purchase at the Wide World of Sports concession stand.

### **Prior-Day Check-In**

- You may check in the day before the trial online by clicking Prior-Day Check-In at the top of my website. You may check yourself in or mark yourself Absent, if you know you will be unable to attend. This will decrease the number of people crowding around the gate sheets. Prior-Day Check-In will only show the day before the trial and is available from noon -5pm only. After 5pm, this feature will be shut off to allow us to print gate sheets for the next day.
- You can receive a text alert, at noon, as a reminder to check-in. You may enable this feature by going to my website, click on your name and then ALERTS.

### **Real-Time Run Order**

- Real-Time Run-Order will be in use for this trial. Click on Run-Order at the top of my screen each day. The run order will update every few minutes. This will allow you to plan when you will be in the ring with your dog.

### **Results Matter**

- All results will continue to be posted after the trial. Our new feature will keep track of results for your dog. You may access these results by clicking on your dog's name in your record OR by clicking on **My Entries/Results**. Results will be posted throughout the day.
- You can get a text alert with your results sent directly to your phone, by the end of each class. Sign up for Alerts by clicking on your name, then **Alerts**.
- Click Text will be sent only for Q's if you only want the good stuff!!
