Move-Ups

- Move-ups must be processed by 6pm on Monday, June 1, 2026, per AKC.
- If you paid on-line, you may process your move-up by clicking on MOVE-UP on PawPrint Trials and change the appropriate class.
- If you mailed your entry in, you must email me to request a move-up. Please include the class you are moving from and the class you are moving to.
- **No** move-ups will be done after the posted deadline.
- **If you earn a title during the trial, you must complete a move-up form and submit it before the end of the day. On-line move-ups are not allowed. If a move-up form is not submitted at the trial, your move-up cannot be processed.**

Jump Height Cards

- All dogs competing in agility must possess an Official AKC or valid yellow measuring form.
- **This trial WILL have a VMO.**
- All dogs that do not have a temporary or permanent card must be measured PRIOR to running.
- Measuring will occur throughout the day. Please arrive in plenty of time to be measured before you walk the course.

Prior-Day Check-In

- You may check in the day before the trial online by clicking Prior-Day Check-In at the top of my website. You may check yourself in or mark yourself Absent, if you know you will be unable to attend. This will decrease the number of people crowding around the gate sheets. Prior-Day Check-In will only show the day before the trial and is available from noon -5pm only. After 5pm, this feature will be shut off to allow us to print gate sheets for the next day.
- You can receive a text alert, at noon, as a reminder to check-in. You may enable this feature under ALERTS.

Real-Time Run Order

- Real-Time Run-Order will be in use for this trial. Click on Run-Order at the top of my screen each day. The run order will update every few minutes. This will allow you to plan when you will be in the ring with your dog.

Results Matter

- All results will continue to be posted after the trial. Our new feature will keep track of results for your dog. You may access these results by clicking on your dog's name in your record OR by clicking on **My Entries/Results**. Results will be posted throughout the day.
- You can get a text alert with your results sent directly to your phone, by the end of each class. Sign up for Alerts by clicking on your name, then **Alerts**. We hope you enjoy these new enhancements to PawPrint Trials.

Maps

- There will be no paper copies for maps. They will be posted at www.pawprinttrials.com by 7:00am the morning of the trial, per AKC.

Food

- There is no food or water available to purchase. No dogs are allowed in the lobby. You may eat in the lobby.

Set Up

- Exhibitors can set up any time after 7:00am each morning.
- Walk thru begins at 7:45am, judging begins at 8:00am.

Site info

- No dogs are allowed in the lobby.
- Restrooms are located to the right, as you enter the lobby from outside.

Parking

- Please take the time to park appropriately and straight. Please do not take up multiple spots with one vehicle.

Entrance and Exit

- From front of the building, enter/exit with your dog at the door on the left side of building. Crating is immediately inside the door.

Crating

- Crating will be in rows with a center aisle to allow for walking.
- X-pens will be limited to 8 panels, for 3 or more dogs. No multiple X-pen setups. Puppy Play Pens may be limited to 2 or more dogs.
- LOUNGE CHAIRS and TABLES will not be allowed, and we ask that you stack crates whenever possible. There will be no "preferred" crating.
- Please be respectful of the trial committee if you are asked to move your setup to make room for others.
- Crate-aggressive dogs must be covered and may not be positioned on the corners of aisle ways or other heavy traffic areas. This will be enforced and if complaints are received, dogs will be moved.

FROM RT. 91 SOUTH: Take Exit 14 for East Center Street toward CT-150/Wallingford. Turn left on East Center Street. Turn right onto Northford Road and continue onto Woods Hill Road. Turn right onto CT-17 South. Continue onto CT-22 East. Turn right on Augur Road.

FROM RT. 91 NORTH: Take Exit 9 for Montowese Avenue. Turn right on Montowese Avenue. Take slight left on Middletown Avenue. Turn right onto Half Mile Road and continue onto Augur Road Extension. Turn left on Totoket Road. Turn right on Augur Road.
